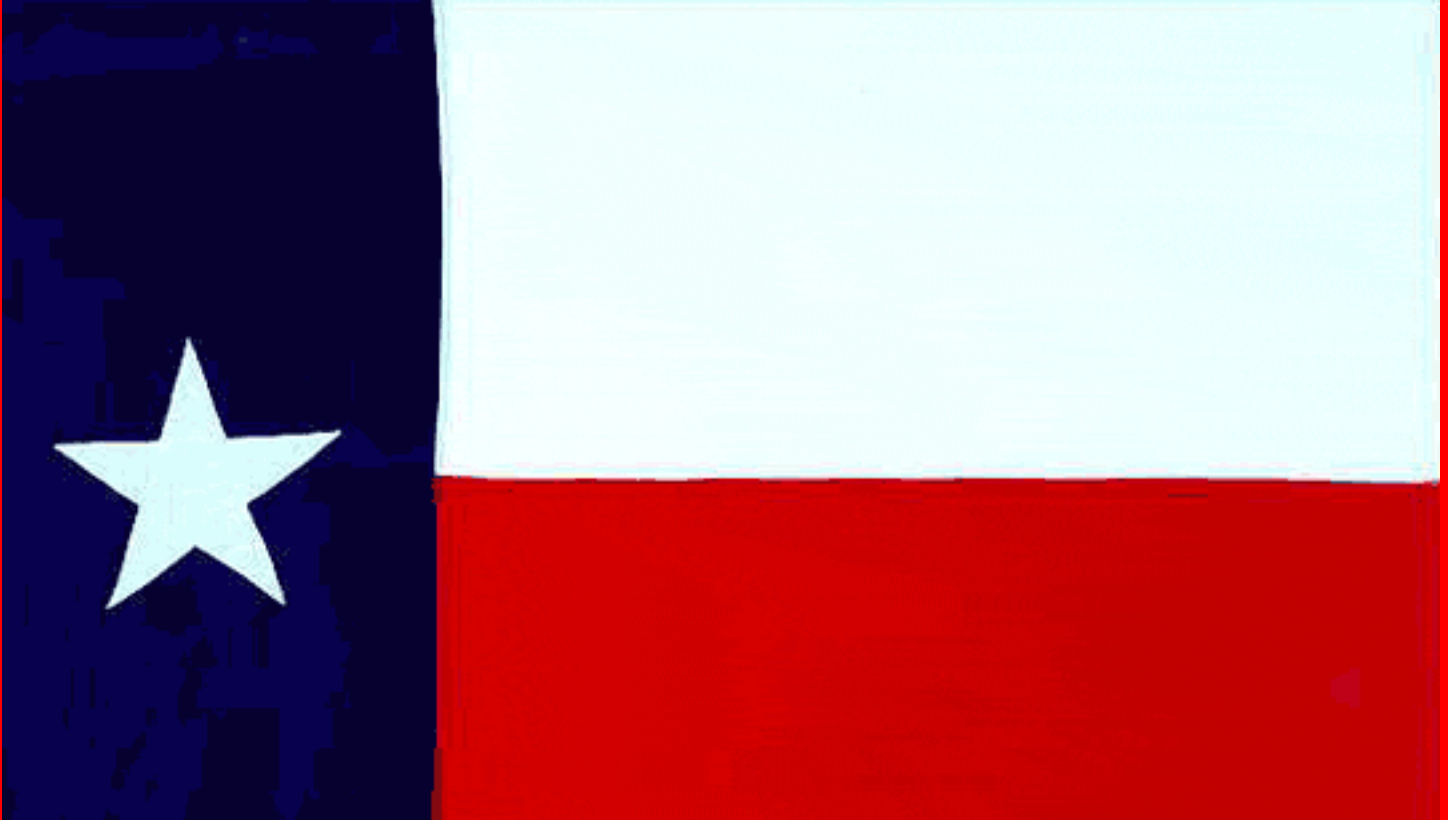

Payments for exhibit space will be returned in that event, except that any actual expenses incurred in connection with the exhibition will be deducted if the exhibition is called off 90 days or less prior to the opening date because of fire, or force majeure, or the public enemy, or strike, or epidemic, or any law, regulation, or public authority that makes it impossible or impractical to hold the exhibition

Exhibitors agree to maintain such insurance that will fully protect, hold harmless and indemnify the exhibition management and the sponsor from any and all claims of any nature whatsoever, including claims under the Workman's Compensation Act, and for personal injury, including death, which may raise in connection with the installation, operation or dismantling of the exhibitor's display.
